We have recently filed a complaint to FCC - Federal Communications Commission on behalf of the 300+ Civilian Victims throughout the United States of America that have filed incident reports with us who are experiencing Havana Syndrome attacks, similar to what government workers and their families have been suffering from.

We are simply seeking help for these Victims.

Re: Consumer complaint regarding 'Noise Harassment'.

Dear Sir or Madam,

"We are filing this formal complaint with the Federal Communications Commission on behalf of American civilians who have reported symptoms consistent with the microwave auditory effect, also known as the Frey effect. Victims have informed DEW Police, a non-profit organization, that they are being subjected to persistent, harmful, and focused sound waves projecting voices and tones.

Given the FCC's jurisdiction over radio wave and microwave-emitting devices, we urge your field agents to conduct a full investigation into these allegations. The reports indicate that the phenomena are particularly acute and intrusive when victims are in their homes, suggesting a targeted and specific source of radio frequency (RF) energy."

Summary of the issue:

The victims report experiencing a constant auditory assault of buzzing, humming, and pulsing sounds, punctuated by verbally abusive and manipulative voices. These noises torment them 24/7. Some victims believe the sounds originate from a satellite overhead, while others suspect a nearby neighbor. However, no one has been able to definitively locate the source

Details of interference:

- Date(s) of occurrence: Every day
- Time(s) of occurrence: Continuously throughout the day and overnight. Majority reported between the overnight hours of 1am to 5am.
- Frequency: An audio analysis was done for some victims. A few of the weapons systems frequencies that were picked up at;
 - * 421 hertz range to 436 hertz range. – Massachusetts
 - * 3,122 hertz range to 3,142 hertz range. – California
 - * Pulsed weapons system – specifically at 723 hertz range to 795 hertz range - North Carolina.

Those are just a few.

Victims efforts to resolve the issue:

The following steps were taken to identify and mitigate the problem; all did not work 100%.

- White noise machines.
- Fans
- EMF shielding
- Faraday cage
- Victims play their personal music, but the volume of the external noise comes through.
- Victims tried to report to local Police and were turned away.

Despite the protections offered by the Noise Control Act of 1972 and the Quiet Communities Act of 1978, the problem of noise harassment persists. As the number of victims grows each day, it is evident that these federal statutes are being openly violated

The FCC is requested to investigate this matter and take appropriate enforcement action to resolve this harmful noise torture.
